

**« Séances de Magasinages et Métamorphoses
avec Jean Airoidi » Draw**

Contest regulations

1. The draw for « **Séances de Magasinages et Métamorphoses-beauté avec Jean Airoidi** » is organized by Productions Audace with the participation of Complexe Desjardins and will be held on September 11, 2010.

Contest details

2. This contest is open to all Quebec residents 18 years of age and over, excluding employees of the shopping centres hosting the event, employees of the boutiques in these shopping centres, of their affiliated companies, of the participating stores and of their advertising and promotional agencies, as well as their immediate family members living under the same roof.
3. Participants may obtain entry forms in the central court at Complexe Desjardins the day of the event, namely September 11, 2010.
4. To enter, participants must fill out the entry form, printing their name, address, age, telephone No., e-mail address and the name of Complexe Desjardins. Entry forms must be placed in the official entry box located in the central court at Complexe Desjardins no later than 12 noon on September 11, 2010.
5. Limit of one entry form per person.
6. No purchase necessary.

Prize draw

8. The random draw, followed by the announcement of the winners' names, will take place on the main stage in the central court at Complexe Desjardins two times on September 11, 2010, at approximately 10 a.m. and 1 p.m.

General conditions

9. The winner must be present in the central court at Complexe Desjardins to claim his/her prize at the time of the draw (door prize-type draw). If the winner does not come forward after his/her name has been called three times, another entry form will be randomly drawn, and so forth.

All decisions by the organizers with regard to this paragraph shall be final and without appeal.
